- Triple rinse empty container in the following manner: Invert the empty container over the spray or mixing tank and allow to drain for at least 30 seconds after the flow has slowed down to a drip. Thereafter rinse the container three times with a volume of water equal to a minimum of 10% of that of the container. Add the rinsings to the contents of the spray tank before destroying the container in the prescribed manner.
- Destroy empty container by perforation or flattening and do not use for any other purpose. Dispose in a responsible manner and according to local legislation.
- Do not burn empty container or product.
- Before spraying remove animals and pets from the areas to be treated. Cover or remove (as applicable) fish ponds, aquariums, etc. before spraying.
- Cover or remove any open food and water containers.
- Do not apply to surfaces where food is handled or stored.
- Prevent contamination of food, feed, eating utensils and drinking water.

MIXING INSTRUCTIONS

Invert the **ATTRATHOR™ TARGETED INSECTICIDE** container several times to ensure thorough mixing of concentrate. Half fill the spray tank with clean water and then add the required quantity of **ATTRATHOR™ TARGETED INSECTICIDE**. Stir mixture and then top up the spray tank to the required volume with clean water.

The use of this product in a tank mix with other insecticides is not recommended as the behaviour and efficacy of the product may be affected. Ensure equipment is clean.

GENERAL INSTRUCTIONS

ATTRATHOR™ TARGETED INSECTICIDE is recommended for use as a targeted indoor crack and crevice treatment for cockroaches. It can be used in warehouses, restaurants, food manufacturing, processing and storage plants, supermarkets, hotels, hospitals, domestic and other similar situations.
